\*Southbridge School Committee Policy BEDH (Feb. 2015) provides guidelines for public input at School Committee meetings: Topics for public comment should be relative to the responsibility of the Committee: policy, curriculum, budget, health and safety, district goals; speakers will be allowed three (3) minutes to present their material. The presiding Chairperson may permit extension of this time limit; at the discretion of the Chairperson, topics for discussion may be limited to those items listed on the School Committee agenda for that evening; improper conduct and remarks will not be allowed. Defamatory or abusive remarks are always out of order. If a speaker persists in improper conduct or remarks, the Chairperson may terminate that individual’s privilege of address. All remarks will be addressed through the Chairperson of the meeting. Speakers may offer such objective criticisms of the school operation and programs that concern them, but in public sessions the Committee will not hear personal complaints of personnel nor any member of the school community. Under no circumstances, administrative channels are the proper means for disposition of legitimate complaints involving staff members.
